Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

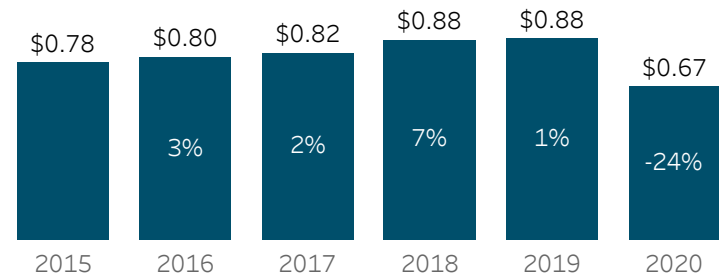

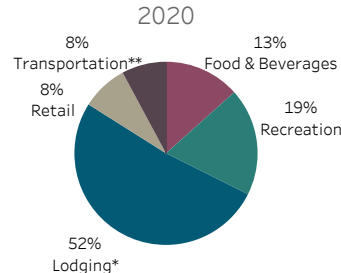
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Moore County generated:

- \$1,839 in daily expenditures
- \$295 in daily labor income
- \$60 in daily state taxes
- \$99 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Moore county, each household pays:

- \$22 less in state and local taxes
- \$8 less in state taxes
- \$14 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Moore County household would pay \$22 more in state and local taxes.

RANKING

In 2020, Moore County ranked **95** of 95 counties in visitor spending, compared to **95** in 2019.
