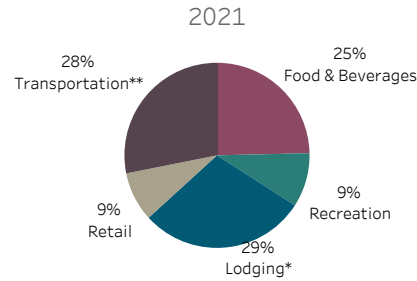
VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

IMPACT PER DAY

On an average day in 2021, visitor spending in Wayne County generated:

- \$24,943 in daily expenditures
- \$6,967 in daily labor income
- \$1,169 in daily state taxes
- \$947 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Wayne county, each household pays:

- \$135 less in state and local taxes
- \$74 less in state taxes
- \$60 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Wayne County household would pay **\$135** more in state and local taxes.

RANKING

In 2021, Wayne County ranked
72
of 95 counties in visitor spending,
compared to 71 in 2020.
