Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

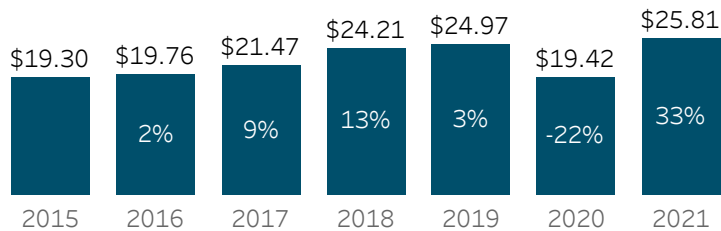

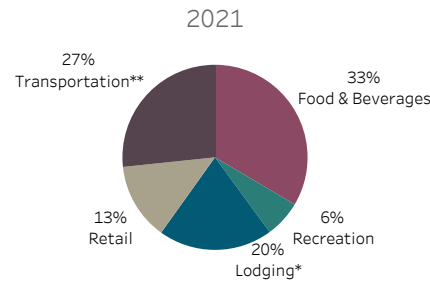
## VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

## IMPACT PER DAY

On an average day in 2021, visitor spending in Lawrence County generated:

- \$70,709 in daily expenditures
- \$17,700 in daily labor income
- \$3,364 in daily state taxes
- \$2,570 in daily local taxes

## IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Lawrence county, each household pays:

- \$134 less in state and local taxes
- \$76 less in state taxes
- \$58 less in local taxes

## IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Lawrence County household would pay **\$134** more in state and local taxes.

## RANKING

In 2021, Lawrence County ranked  
**46**  
of 95 counties in visitor spending,  
compared to 47 in 2020.
