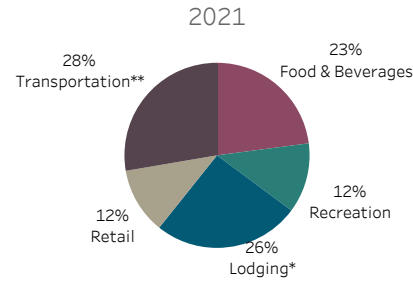
VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

This report should not be compared with versions published before 2020 due to the changes in vendor and model.

IMPACT PER DAY

On an average day in 2021, visitor spending in Franklin County generated:

- \$151,074 in daily expenditures
- \$38,950 in daily labor income
- \$6,861 in daily state taxes
- \$4,885 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Franklin county, each household pays:

- \$260 less in state and local taxes
- \$152 less in state taxes
- \$108 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Franklin County household would pay **\$260** more in state and local taxes.

RANKING

In 2021, Franklin County ranked **35** of 95 counties in visitor spending, compared to 34 in 2020.
