Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

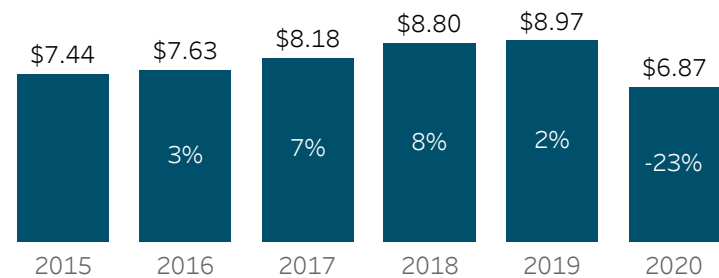

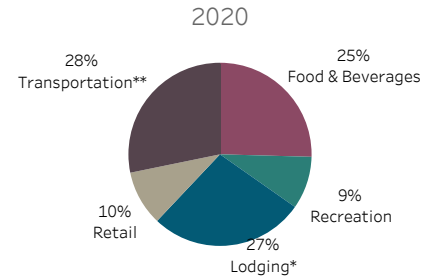
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Wayne County generated:

\$18,757 in daily expenditures

\$6,290 in daily labor income

\$871 in daily state taxes

\$788 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Wayne county, each household pays:

\$105 less in state and local taxes

\$55 less in state taxes

\$50 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Wayne County household would pay **\$105** more in state and local taxes.

RANKING

In 2020, Wayne County ranked

71

of 95 counties in visitor spending,
