Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

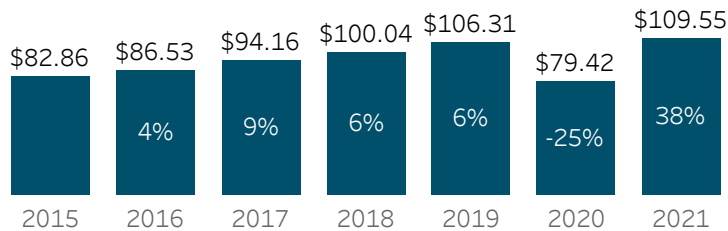

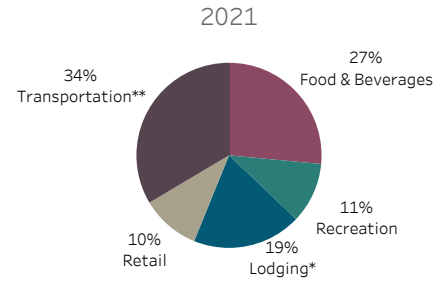
## VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

This report should not be compared with versions published before 2020 due to the changes in vendor and model.

## IMPACT PER DAY

On an average day in 2021, visitor spending in Maury County generated:

- \$300,138 in daily expenditures
- \$73,839 in daily labor income
- \$13,525 in daily state taxes
- \$10,376 in daily local taxes

## IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Maury county, each household pays:

- \$248 less in state and local taxes
- \$140 less in state taxes
- \$108 less in local taxes

## IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Maury County household would pay \$248 more in state and local taxes.

## RANKING

In 2021, Maury County ranked 20 of 95 counties in visitor spending, compared to 21 in 2020.
