Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

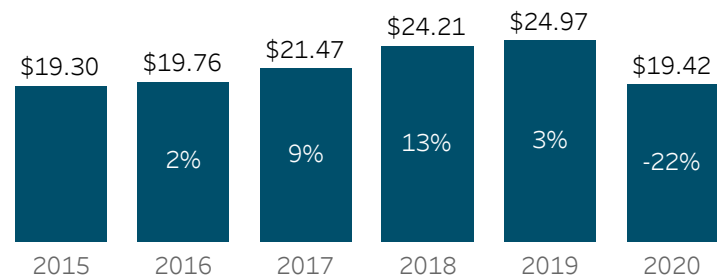

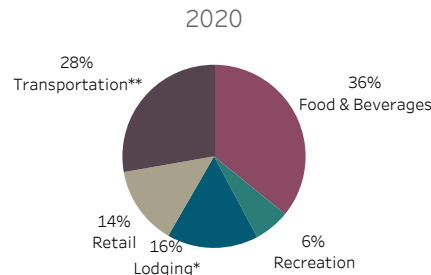
### VISITOR SPENDING OVER TIME

### IMPACT PER DAY

On an average day in 2020, visitor spending in Lawrence County generated:

- \$53,066 in daily expenditures
- \$14,896 in daily labor income
- \$2,451 in daily state taxes
- \$2,100 in daily local taxes

### IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Lawrence county, each household pays:

- \$104 less in state and local taxes
- \$56 less in state taxes
- \$48 less in local taxes

### IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Lawrence County household would pay \$104 more in state and local taxes.

### RANKING

In 2020, Lawrence County ranked **47** of 95 counties in visitor spending, compared to **44** in 2019.
