Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

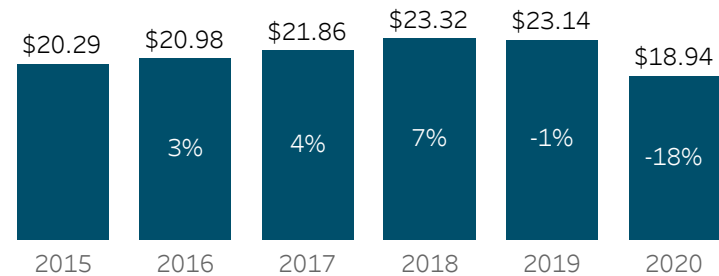

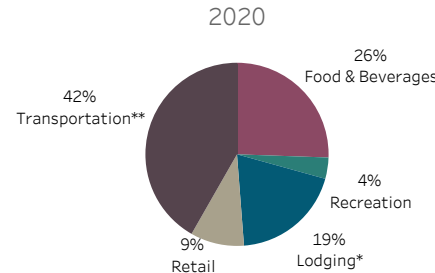
### VISITOR SPENDING OVER TIME

### IMPACT PER DAY

On an average day in 2020, visitor spending in Giles County generated:

- \$51,753 in daily expenditures
- \$11,933 in daily labor income
- \$2,016 in daily state taxes
- \$1,966 in daily local taxes

### IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Giles county, each household pays:

- \$122 less in state and local taxes
- \$62 less in state taxes
- \$60 less in local taxes

### IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Giles County household would pay \$122 more in state and local taxes.

### RANKING

In 2020, Giles County ranked **50** of 95 counties in visitor spending, compared to **49** in 2019.
