Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

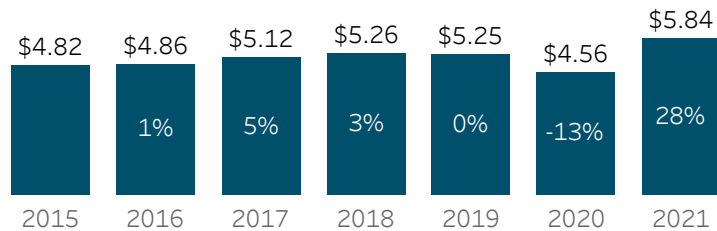

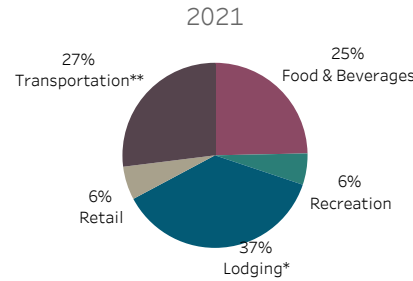
VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

This report should not be compared with versions published before 2020 due to the changes in vendor and model.

IMPACT PER DAY

On an average day in 2021, visitor spending in Perry County generated:

- \$15,999 in daily expenditures
- \$2,584 in daily labor income
- \$483 in daily state taxes
- \$645 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Perry county, each household pays:

- \$141 less in state and local taxes
- \$60 less in state taxes
- \$80 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Perry County household would pay \$141 more in state and local taxes.

RANKING

In 2021, Perry County ranked
84
of 95 counties in visitor spending,
compared to 84 in 2020.
