Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

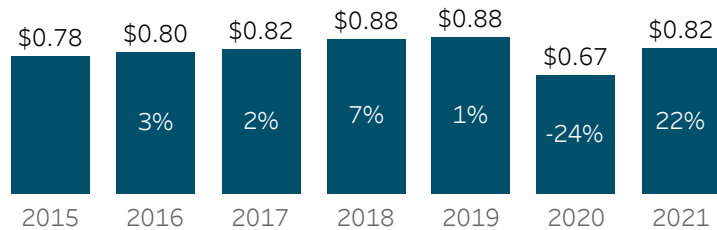

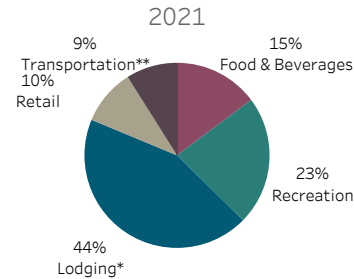
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2021, visitor spending in Moore County generated:

\$2,252 in daily expenditures

\$341 in daily labor income

\$84 in daily state taxes

\$111 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Moore county, each household pays:

\$27 less in state and local taxes

\$12 less in state taxes

\$16 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Moore County household would pay \$27 more in state and local taxes.

RANKING
