Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

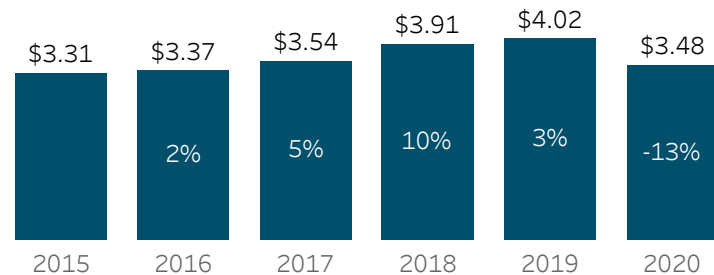

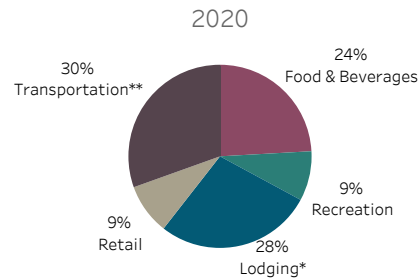
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Lewis County generated:

- \$9,501 in daily expenditures
- \$1,778 in daily labor income
- \$431 in daily state taxes
- \$395 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Lewis county, each household pays:

- \$64 less in state and local taxes
- \$33 less in state taxes
- \$31 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Lewis County household would pay \$64 more in state and local taxes.

RANKING

In 2020, Lewis County ranked **87** of 95 counties in visitor spending, compared to **88** in 2019.
