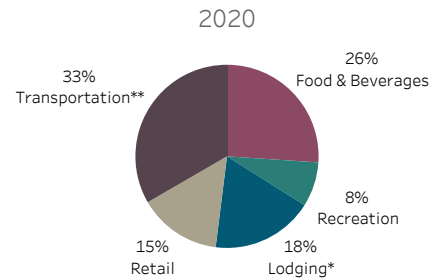
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Lincoln County generated:

- \$59,519 in daily expenditures
- \$14,400 in daily labor income
- \$2,621 in daily state taxes
- \$2,148 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Lincoln county, each household pays:

- \$129 less in state and local taxes
- \$71 less in state taxes
- \$58 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Lincoln County household would pay \$129 more in state and local taxes.

RANKING

In 2020, Lincoln County ranked **43** of 95 counties in visitor spending, compared to **42** in 2019.
