Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

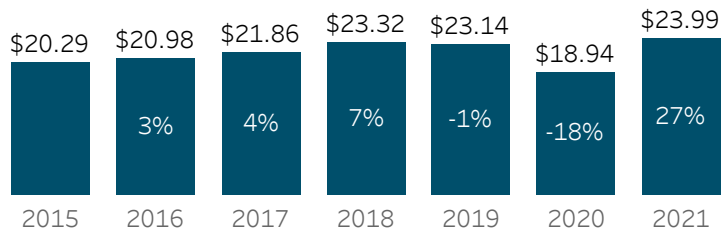

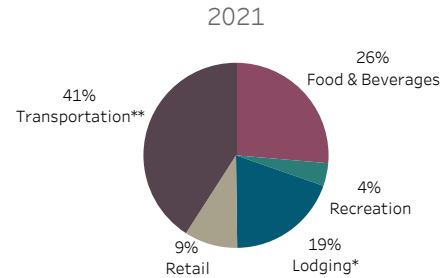
VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

This report should not be compared with versions published before 2020 due to the changes in vendor and model.

IMPACT PER DAY

On an average day in 2021, visitor spending in Giles County generated:

- \$65,729 in daily expenditures
- \$13,946 in daily labor income
- \$2,636 in daily state taxes
- \$2,279 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Giles county, each household pays:

- \$153 less in state and local taxes
- \$82 less in state taxes
- \$71 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Giles County household would pay **\$153** more in state and local taxes.

RANKING

In 2021, Giles County ranked **50** of 95 counties in visitor spending, compared to 50 in 2020.
