Due to changes in vendor, economic impacts for the state all counties for the past 10 years were adjusted in 2020.

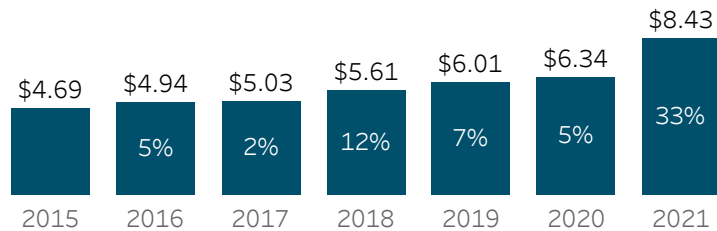

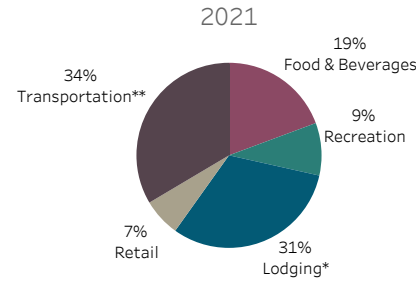
## VISITOR SPENDING OVER TIME

## IMPACT PER DAY

On an average day in 2021, visitor spending in Hickman County generated:

**\$23,105** in daily expenditures

**\$3,540** in daily labor income

**\$924** in daily state taxes

**\$866** in daily local taxes

## IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Hickman county, each household pays:

**\$75** less in state and local taxes

**\$39** less in state taxes

**\$36** less in local taxes

## IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Hickman County household would pay **\$75** more in state and local taxes.

## RANKING

In 2021, Hickman County ranked  
**74**  
of 95 counties in visitor spending,  
compared to 75 in 2020.
