Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

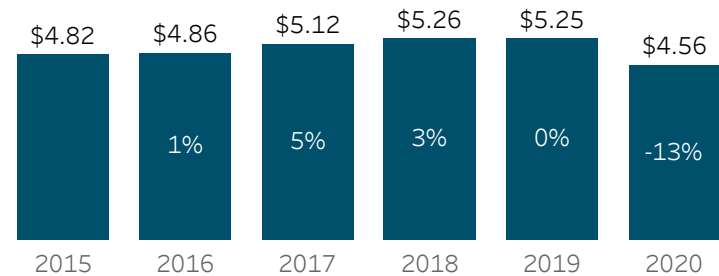

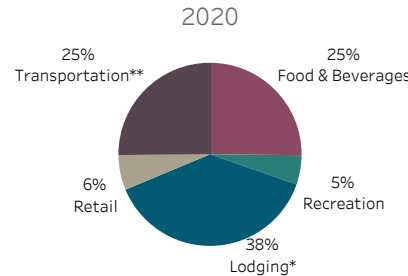
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Perry County generated:

- \$12,467 in daily expenditures
- \$2,233 in daily labor income
- \$364 in daily state taxes
- \$537 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Perry county, each household pays:

- \$107 less in state and local taxes
- \$43 less in state taxes
- \$64 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Perry County household would pay \$107 more in state and local taxes.

RANKING

In 2020, Perry County ranked **84** of 95 counties in visitor spending, compared to **84** in 2019.
