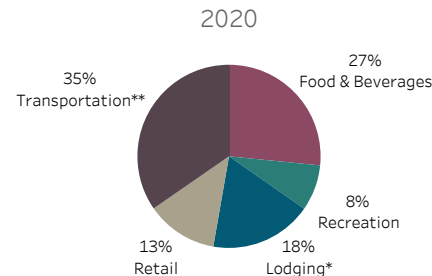
### VISITOR SPENDING OVER TIME

### IMPACT PER DAY

On an average day in 2020, visitor spending in Coffee County generated:

- \$244,925 in daily expenditures
- \$68,936 in daily labor income
- \$11,028 in daily state taxes
- \$8,323 in daily local taxes

### IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Coffee county, each household pays:

- \$327 less in state and local taxes
- \$186 less in state taxes
- \$141 less in local taxes

### IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Coffee County household would pay \$327 more in state and local taxes.

### RANKING

In 2020, Coffee County ranked **19** of 95 counties in visitor spending, compared to **19** in 2019.
